

## Obligation to observe confidentiality for students at Ulm University Hospital

was informed in detail today about the relevant requirements of medical confidentiality (§ 203 StGB in conjunction with § 9 BOÄ), data protection (§ 6 LDSG BW - data confidentiality) and general confidentiality and was obliged in writing to comply with them.

I will process and use the personal data (e.g. patient data or employee data) that comes to my knowledge in the course of my medical training at Ulm University Hospital and other institutions exclusively for the purposes related to the respective lawful fulfilment of my duties. The duty of confidentiality covers all information about a patient (such as personal, material, medical and social aspects) regardless of the form it takes. I have been informed that I am liable to prosecution under Section 203 of the German Criminal Code (StGB) if I disclose such secrets.

Furthermore, I have been informed that the unauthorised collection, storage, transmission, use or other utilisation of personal data is prohibited under the provisions of data protection law.

Furthermore, I am obliged to maintain confidentiality vis-à-vis third parties about all private, company and business secrets as well as other confidential internal Hospital matters that come to my knowledge during my training.

Third parties in this sense are all persons who are not involved in the treatment of a patient. This also includes my fellow students, the patient's relatives as well as my own family members.

In the context of medical education and training, the identifiable patient reference must be removed if it is no longer necessary for the purpose of education and training.

Insofar as the disclosure of patient data is necessary in the context of my training, I may only do so in anonymised or pseudonymised form (case data without personal data) unless a declaration of release from confidentiality has been made.

I undertake to maintain confidentiality about all Hospital matters of a confidential nature (in particular work results from research projects; ideas/inventions received for information) both during the duration of the training and after its termination.

Furthermore, I undertake to properly store all confidential documents made available to me and to ensure that third parties cannot inspect or take note of them. As soon as the documents are no longer required, I will either return them without being asked or dispose of them with adequate safeguards. The decision on this will be made by the respective head of training or department. I will dispose of any working copies as soon as they are no longer required using a document shredder with protection class 2 and security level 4 (in accordance with DIN 99366) at the Hospital.

During my training at Ulm University Hospital, I will strictly comply with the regulations on confidentiality according to the German Criminal Code (medical confidentiality) and general secrecy as well as the provisions of data protection law.

This obligation continues after the end of my training.

I am aware that violations of the duty of confidentiality pursuant to § 203 of the German Criminal Code (StGB) and of data protection law may be prosecuted under criminal law as well as under professional law.

I have received a copy of this declaration of commitment as well as an information sheet on data protection and the duty of confidentiality with the relevant legal texts.

I hereby declare that I have understood the contents of this declaration.
